## **Audit Report**

Mike D. Brynjulfson, CPA, the independent auditor for both charter schools, gave the results of the audits concluding on June 30, 2015. The auditor stated that LMS and MMS received all clean reports with both schools in compliance and having no internal control deficiencies.

Josie Hill gave the current financial reports for LMS and MMS. Both reports displayed a positive net income through August 2015.

Josie Hill also reported that for 2015-16 Lakeland Montessori Schoolhouse is working with Lake Mary Montessori Academy for curriculum coaching for all classrooms. Lake Mary Montessori Academy is an American Montessori Society accredited school for ages 3-12.

## Academic and general reports:

Review state assessment results:

- Heather Manrow reported that FSA Reading and Math results for 2014-2015 were released yesterday at 6 a.m. in the form of T-scores and percentile rankings. She also said there will be 5 achievement levels. Parent reports will be available to send home in mid-October.
- Lori DeAngelis asked if there was a sense or overall reaction to the results. Heather Manrow said we are within the mean or above.
- 6th grade English Language Arts- We had the highest of the reported T-scores in the county.
- 8th grade English Language Arts We had the highest of the reported T-scores in the county.

Heather Manrow reviewed the chart below. She stated that FSA is not represented below. Progress monitoring data is listed below. Also, values of "na" indicate areas of no high stakes end of the year test and are not in the accountability plan.
